## 1. CONTROLLER / TRADER

## 2. SCOPE

These Terms apply to: (a) your use of this website and its enquiry forms, and (b) accommodation and related services provided at our autocamp, apartment and mobile home. Bookings may be made via our web forms, email/phone/WhatsApp/Facebook/Instagram, walk-ins, and OTAs. For OTA bookings, the OTA's terms also apply and the OTA may act as an independent controller.

## 3. DEFINITIONS

“Website” means all pages under the domain [www.autocamp-stellamaris.com](http://www.autocamp-stellamaris.com). “User” means any natural or legal person accessing or using the Website. “Guest” means a person who books or stays at the autocamp, apartment or mobile home. “We/Us” means U.O. STELLA MARIS (obrt) as above.

## 4. PRICES, TAXES & DEPOSITS

Prices are in EUR; tourist tax applies per law. Advance deposit: 30% to confirm any reservation. Payment methods: bank transfer; cash (EUR); POS cards (Visa, JCB, Discover, Diners, Maestro, Mastercard). Cash discount: at least 5% on eligible base rates. Security/damage deposit (Apartment & Mobile Home): €200 (cash or card pre-authorization), refundable at checkout after inspection (card releases per your bank's timelines).

**5. CHECK-IN / CHECK-OUT & HOUSE RULES**

Autocamp: check-in from 09:00; check-out by 10:00. Apartment/Mobile Home: check-in from 14:00; check-out by 10:00. Quiet hours: 23:00–07:00. Pets per rules; no indoor smoking; unregistered visitors may not stay. See the full House Rules for details.

**6. MINIMUM STAY & PROMOTIONS**

Minimum stay: 3 nights. Seasonal promotions (e.g., “Stay 7, pay 6” from 15 May–30 June & 1 Sept–15 Oct) are capacity-limited and non-cumulative.

**7. CANCELLATIONS & NO-SHOWS**

Autocamp: free cancellation  $\geq$  7 days before arrival; if  $<7$  days we keep the 30% deposit. No-show: charge first night (or keep equivalent from deposit).

Apartment & Mobile Home: free cancellation  $\geq$  14 days; if  $<14$  days we keep the 30% deposit. No-show: charge first night (or keep equivalent). No 14-day withdrawal right: not applicable to accommodation for specific dates.

**8. ACCEPTABLE USE (WEBSITE)**

You must use the Website in accordance with Croatian law and good practice. You agree not to upload, post or transmit content that is unlawful, threatening, defamatory, invasive of privacy, obscene, offensive, or otherwise objectionable; that infringes third-party rights; that advertises products/services without our prior written consent; or that restricts or inhibits other users' enjoyment of the Website. You must not attempt to gain unauthorized access to the Website, servers or networks connected to it, or interfere with its operation.

## 9. INTELLECTUAL PROPERTY

All materials on the Website (including text, photos, graphics, logos, layout and design) are our property or used under licence and are protected by applicable IP laws. Except as permitted by mandatory law, you may not copy, distribute, modify, publish, transmit, or commercially exploit any part of the Website without our prior written permission. You are responsible for the equipment and connectivity needed to access the Website and for associated costs. While we aim for high availability, the Internet may experience interruptions beyond our control; we are not responsible for data loss or other issues arising from such events.

## 12. MONITORING & TERMINATION

We may monitor Website areas (including interactive parts) to check compliance with these Terms and applicable law, and may remove content or restrict/suspend access where reasonably necessary.

To the extent permitted by Croatian law, we exclude liability for indirect or unforeseeable loss and for events of force majeure. Nothing excludes liability for intent or gross negligence. Use of the Website is at your own risk.

If any provision is invalid, the remainder remains in force and the invalid provision is replaced by a valid one closest in purpose. Failure to enforce a provision is not a waiver.

## 2. DEFINITIONS

## 3. DATA WE COLLECT & LEGAL BASES

### Website enquiries & bookings

Contact details, dates, party size, message, and channel metadata – for pre-contract steps and performing the contract (Art. 6(1)(b)), compliance with consumer/accounting law (Art. 6(1)(c)), and service quality (Art. 6(1)(f)).

### Guest registration (eVisitor)

Identity document data as required by Croatian tourism/tax law – legal obligation (Art. 6(1)(c)); guests are registered within 24 hours of arrival.

### Payments

Payer identifiers, masked card/transaction references (via POS), sums and receipts – contract and legal obligation (Art. 6(1)(b)(c)).

**CCTV**

Video surveillance at reception, parking, internal road and exterior of accommodation units (never inside units or sanitary areas) – legitimate interests in security (Art. 6(1)(f)). Retention: 30 days unless footage is needed longer for incidents/claims.

**WI-FI**

We provide guest Wi-Fi (Starlink). We do not keep connection/MAC/IP logs beyond what is necessary to provide the service; no marketing use.

**COOKIES & SIMILAR TECH**

We use a consent banner (CookieYes). Non-essential tools are blocked until you consent: GA4 (via GTM), YouTube embeds, Google Maps, and reCAPTCHA. Legal basis: consent (Art. 6(1)(a)). See Cookie Policy.

**4. SOURCES**

Data comes directly from you (forms, email, OTA reservations forwarded to us) and from your lawful use of our site. OTAs act as independent controllers – see each OTA's privacy policy.

**5. WHERE WE STORE/PROCESS DATA**

Hosting is provided by Plus Hosting Grupa d.o.o. (Croatia/EU). If you consent to Google services (e.g., GA4/Maps/YouTube/reCAPTCHA), data may be processed outside the EEA (e.g., USA) under appropriate safeguards (see International transfers).

**6. RECIPIENTS/PROCESSORS**

**8. SECURITY MEASURES**

We apply organisational, physical and technical safeguards (access controls, encryption in transit, hardened hosting, staff confidentiality, processor contracts, CCTV access controls). Despite safeguards, no Internet service can be 100% secure.

**9. RETENTION**

Enquiries not resulting in a stay: normally up to 12 months.  
Guest/booking and invoice/accounting records: 11 years (statutory).  
CCTV: 30 days (longer only if needed for incidents/legal claims).  
Cookie consent logs: typically 12–24 months (CMP setting).

**10. YOUR RIGHTS**

Access, rectification, erasure, restriction, portability, objection (including to processing based on legitimate interests), and withdrawal of consent (without affecting prior processing). You can lodge a complaint with AZOP.

**11. CHILDREN**

We do not knowingly contract online with children under 16 without parental authorisation.
